There are three unique and different scholarships on the enclosed brochure. The three organizations have worked together to establish a single form, however the form needs to be completed and submitted to the appropriate places for each different organization in order to be considered. The following is information related only to the Friends of Nursing Scholarship.

1. Please appoint a faculty representative to function as the school Liaison. The Liaison will submit scholarship finalists to the FON Scholarship Committee.
2. Students should submit completed scholarship applications to the Liaison by **October 30, 2010**.
3. The Liaison with their committee will select 3 finalists from all applicants and interview the 3 finalists to be put forward to the FON Scholarship Committee.
4. Liaisons send the finalists' application paperwork (including the interview score) by mail or in person to the FON Liaison Coordinator Dr. Pamela Stoeckel by **January 3, 2011**.
5. A "letter of award" and scholarship check will be awarded to each candidate at the Spring Luncheon in April 2011. Information about the Spring Luncheon will be sent at a later date.
