Important details:

Fees: Art/ Food/Info Vendor Booths: \$20.00 for a 10' x10' space, plus \$10.00 for each additional 10'x10' space. Fee must accompany application. Fees will be returned if vendor is not accepted (for example, if there are already similar vendors contracted) but no fees will be returned to those who do not show up to participate. Licenses: Vendors are responsible for having city and state tax licenses. State Special Event License is located online at <http://www.colorado.gov/cms/forms/dor-tax/dr0589.pdf> The fees are prorated for multiple events or \$8 for a single event.

Fees are \$15 for the year or no charge for a one time event.
